Regulatory updates:

- CDC has added [six new COVID symptoms to watch for](#) (previously fever, cough and shortness of breath) now also includes: chills, repeated shaking with chills, muscle pain, headache, sore throat, new loss of taste or smell.

- New toolkit on [telehealth from CMS](#)- this primary audience is states in helping to roll out expanded services for Medicaid and CHIP populations. In the coming days, several of the initial state-wide stay at home orders are due to expire, here is a brief update that covers most of the states where our team lives and works:
 - **North Carolina**- The governor has [extended the stay at home order](#) until Friday May 8th and outlined a 3 step plan that will start sometime after 5/8 for [re-opening the state](#). In order to begin, several criteria need to be met (slide 14/17)- (*In phase one, the stay at home order is to stay in place for at least 2-3 weeks until ok to enter phase two*)- Announcement on schools planned for today (currently closed through May 15th).
 - **Virginia**- [Stay at home order from 3/30/2020](#) in effect until June 10, 2020, schools closed to in-person instruction rest of school year.

- **South Carolina-** On Monday (4/20) executive orders were issued to reopen some [businesses and beaches](#) on 4/20 at 5pm and beaches on 4/21. Schools closed to in-person instruction for remainder of 2019-2020 year.
- **Georgia-** Certain businesses reopening today (4/24) including: gyms, tattoo shops, hair salons, bowling alleys, with more on Monday (4/27): movie theatres, restaurants will allow in-person dining, and the stay at home order is lifted 4/30. Schools closed for the remainder of the academic year.

News Updates:

- FDA has authorized an at-home coronavirus test by LabCorp (called Pixel). New York Times article, requires a doctor's order in most states, purchaser completes on-line survey (first question of HCW or not) patient performs own nasal (not NP) swab. It costs \$119.
- N95 respirator decontamination is being made available at no cost to healthcare facilities and first responder communities through a U.S. Department of Health and Human Services grant awarded to Battelle. The services are available at no charge, except for the logistics to and from the decontamination site.
