FDA:

FDA Authorizes First COVID-19 Test for Self-Testing: The FDA issued an EUA for the Lucira COVID-19 All-In-One Test Kit, a molecular (real-time loop mediated amplification reaction) single-use test. The test has been authorized for home use with self-collected nasal swab samples from individuals (age 14+) who are suspected of COVID-19 by their healthcare provider. <u>Read the FDA announcement</u>.



CDC:

Last week, the CDC provided several holiday updates. Guidance includes tips for <u>Holiday Celebrations and</u> <u>Small Gatherings</u> and <u>wearing masks while using public transportation</u>.

With several vaccine candidates filing and expecting to file for emergency use authorizations (EUAs), the CDC has updated some of its resources for healthcare personnel.
